Pursuant to provisions of Regulation 30 and 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 we would like to inform you that the following business were transacted at the meeting of the Board of Directors of QGO Finance Limited ("The Company") held today i.e., Monday, May 29, 2023 at 11:45 AM and concluded at 12:45 PM have inter alia, considered, approved and taken on record the following:

- 1. Audited Financial Results of the Company for the quarter and financial year ended March 31, 2023 along with Audit Report issued by the Statutory Auditors of the Company for the financial year ended March 31, 2023. Further pursuant to provisions of Regulation 33 (3)(d) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 it is hereby declared that M/s. Subramaniam Bengali and Associates, Chartered Accountants, Statutory Auditors have issued the Audit Reports for the financial year 2022-23 with an unmodified opinion.

We have audited the quarterly financial results of "QGO FINANCE LIMITED" ("the Company") for the quarter ended on March 31, 2023 and year to date Financial results for the period from 1st April 2022 to 31st March, 2023 attached herewith, being submitted by the company pursuant to the requirement of the Regulations 33 of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015, as amended ("the Listing Regulations"). These Quarterly Financial Results as well as the year to date Financial Results have been prepared on the basis of the Interim Financial Statement, which are the responsibility of the company's Management.
